# REGULATIONS UNDER THE LIQUOR LICENSING ACT 1997

## LIQUOR LICENSING (DRY AREAS—SHORT TERM) REGULATIONS 1997

**Citation**

1. These regulations may be cited as the *Liquor Licensing (Dry Areas—Short Term) Regulations 1997*.

**Commencement**

2. These regulations come into operation on the day on which they are made.

**Interpretation**

3. (1) In these regulations, unless the contrary intention appears—

"**the Act**" means the *Liquor Licensing Act 1997*;

"**container**" means the container in which liquor is sealed so that it cannot escape but does not include packaging in which the container is sold;

"**private land**" means any land that is not a public place within the meaning of the Act;

"**street or road**" includes an avenue, terrace, lane, crescent, court, place or other land set aside for the carriage of vehicular traffic.

(2) Unless the contrary intention appears, a reference in these regulations to a street or a road is a reference to—

(a) the carriageway of the street or road; and

(b) the footpaths (if any) of the street or road; and

(c) a median strip or traffic island (if any) or any other land separating carriageways of the street or road; and

(d) any other land adjoining or adjacent to the carriageway of the street or road being land that has been reserved for the purposes of the street or road.

(3) For the purposes of these regulations, a wine cask will be taken to have been opened if the tap comprising part of the container is protruding through the external carton.

**Short term dry areas (s. 131 of the Act)**

4. (1) Subject to subregulation (2), the consumption of liquor or the consumption and possession of liquor are prohibited in accordance with schedule 1 in the areas described in that schedule during the periods specified in that schedule.

(2) The prohibition does not extend to any private land within an area described in schedule 1.

(3) Unless the contrary intention appears, the prohibition in schedule 1 of the possession of liquor in an area does not extend to—

(a) a person who is genuinely passing through the area if—

(i) the liquor is in the original container in which it was purchased from licensed premises; and

(ii) the container has not been opened; or

- (b) a person who has possession of the liquor in the course of carrying on a business or in the course of his or her employment by another person in the course of carrying on a business; or
- (c) a person who is permanently or temporarily residing at premises within the area or on the boundary of the area and who enters the area solely for the purpose of passing through it to enter those premises or who enters the area from those premises for the purpose of leaving the area; or
- (d) such other persons (if any) who are specifically excluded by schedule 1.

**Plans of short term dry areas**

5. (1) Schedule 2 sets out plans of some of the areas described in schedule 1.

(2) If the description of an area in schedule 1 does not coincide with the plan of the area in schedule 2, the description will be taken to be correct.

Commencing at the northern corner of lot 167 then in a south-easterly direction along the north-eastern boundaries of lots 167, 171, 175 and 179 and the projection of that line across Hay Street to the boundary of part Section 271, then north-easterly along the north-western boundaries of part Section 271 and lot 2 in file plan 11114 and the projection of that line across The Cutting Road to the boundary of lot 3 in filed plan 11114, then north-westerly along the south-western boundary of part Section 271 and lot 190 then north-easterly along the north-western boundary of lot 190 and the projection of that boundary to the centre line of B.F. Commencing at the point at which the southern side of the Normanville jetty intersects with the low water mark, then generally south-westerly along the low water mark to the mouth of the Bungala River, then along the northern bank of the river to its intersection with the western boundary of the caravan park, then generally north-easterly, northerly and easterly along the western and northern boundaries of the caravan park to the point at which the northern boundary joins the northern boundary of the tennis courts, then easterly along that northern boundary of the tennis courts to the far side of the entrance to the caravan park, then in a straight line by the shortest route to the south-eastern corner of lot 138 of part Section 1014, Hundred of Yankalilla, then generally north-westerly along the southern boundary of that lot and the southern boundary of lot 137 of part Section 1014, Hundred of Yankalilla and the prolongation in a straight line of the southern boundary of lot 137 to the low water mark, then generally south-westerly along the low water mark to the northern side of the Normanville jetty, then north-westerly, south-westerly and south-easterly along the northern, western and southern sides of the Normanville jetty to the point of commencement.	6.00 p.m. on 31 December 1997 to 6.00 a.m. on 1 January 1998. Commencing at the point at which the prolongation (southward) of the western boundary of the New Alexander Bridge intersects the low water mark, then westerly and south-westerly along the low water mark to the eastern side of the causeway to Granite Island, then southerly, westerly and northerly around the outer boundary of the causeway back to the low water mark on the western side of the causeway, then north-westerly and westerly along the low water mark to the eastern bank of the Inman River, then north-westerly along the eastern bank of the Inman River to its intersection with the prolongation (southward) of the western boundary of Inman Street, then northerly along the prolongation of the western boundary of Inman Street and the western boundary of Inman Street to its intersection with the northern boundary of Victoria Street, then south-easterly along that boundary to its intersection with the western boundary of Torrens Street, then northerly and north-easterly along the western and northern boundaries of Torrens Street to its intersection with the northern boundary of Hindmarsh Road, then north-easterly along that boundary to its intersection with the western boundary of the New Alexander Bridge, then along that boundary and its prolongation (southward) to the point of commencement.
