An Act to amend "The Chaff, Hay, and Fruit Act, 1908."

[Assented to, December 18th, 1913.]

**B**E it Enacted by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:—

1. (1) This Act may be cited alone as "The Sale of Chaff and Hay Act Amendment Act, 1913." Short titles.
- (2) "The Chaff, Hay, and Fruit Act, 1908" (hereinafter called "the principal Act"), may hereafter be cited as "The Sale of Chaff and Hay Act, 1908." No. 964 of 1908.
- (3) The principal Act and this Act may be cited together as "The Sale of Hay and Chaff Acts, 1908 and 1913."
2. This Act is incorporated with the principal Act, and that Act and this Act shall be read as one Act. Incorporation with principal Act.
3. Section 6 of the principal Act is amended—
  - (a) by striking out the words "until the thirty-first day of December, one thousand nine hundred and ten," and Amendment of section 6 of principal Act—Standard weight of bag of chaff.
  - (b) by substituting the words "fifty-six" for the word "forty."
4. Section 7 of the principal Act is amended—
  - (a) by inserting the words "or offer or expose for sale" after the word "sell" in the first line thereof, and Amendment of section 7—Bag of chaff not to be under standard weight.
  - (b) by striking out the remainder of the section after the word "weight" in the second line thereof.
5. (1) Upon

**5.** (1) Upon the sale of any bag or sack of chaff on which bag or sack there is branded or otherwise marked the letter L within a quadrilateral figure, of whatever shape, size, or color such letter or figure may be, the seller shall, notwithstanding any agreement to the contrary, be deemed to have warranted that such bag or sack contains at least seventy pounds avoirdupois weight of chaff, excluding the weight of the bag or sack.

(2) No person shall sell or offer or expose for sale any bag or sack of chaff, which bag or sack is branded or otherwise marked as mentioned in subsection (1) hereof, unless such bag or sack contains at least seventy pounds avoirdupois weight of chaff, excluding the weight of the bag or sack. Any contravention of this subsection shall be deemed to be an offence against the principal Act and shall be punishable accordingly.

**6.** (1) No person shall sell, or expose or offer for sale, chaff in any bag or sack which has contained bonedust or any fertilizer within the meaning of "The Fertilizer Act, 1900."

(2) Any contravention of this section shall be deemed to be an offence against the principal Act, and shall be punishable accordingly.
