## No. 59 of 1964

An Act to amend the Local Courts Act, 1926-1962,  
The Workmen's Liens Act, 1893-1936, and for  
other purposes.

[Assented to 5th November, 1964.]

BE IT ENACTED by the Governor of the State of South  
Australia, with the advice and consent of the Parliament  
thereof, as follows:—

## Short titles.

1. (1) This Act may be cited as the "Statutes Amendment  
(Local Courts and Workmen's Liens) Act, 1964".

(2) The Local Courts Act, 1926-1962, as amended by this  
Act, may be cited as the "Local Courts Act, 1926-1964".

(3) The Workmen's Liens Act, 1893-1936, as amended by this  
Act, may be cited as "The Workmen's Liens Act, 1893-1964".

(4) The Local Courts Act, 1926-1962, is hereinafter referred  
to as "the principal Act".

## Incorporation.

2. This Act is incorporated with the principal Act and that  
Act and this Act shall be read as one Act.

Commence-  
ment.

3. This Act shall commence on a day to be fixed by the  
Governor by proclamation.

4. Section 16 of the principal Act is amended—

(a) by striking out all the words after the word "justice"  
therein ;

(b) by inserting at the end thereof the following sub-  
sections (the previous portion of the section as  
amended by paragraph (a) of this section being  
designated as subsection (1) thereof)—

(2) All such bailiffs except the bailiff of the Local Court of Adelaide shall be appointed and may be removed from time to time by the Attorney-General.

(3) All such clerks and other officers and servants and the bailiff of the Local Court of Adelaide shall be appointed and may be suspended or removed as prescribed by the Public Service Act, 1936-1959.

5. Section 216 of the principal Act is amended by striking out the words "three hundred and twelve" therein and inserting in lieu thereof the words "five hundred and thirty".

6. Section 228 of the principal Act is amended by striking out the words "three hundred and twelve" therein and inserting in lieu thereof the words "five hundred and thirty".

7. Section 259 of the principal Act is amended by striking out the words "three hundred and twelve" in paragraphs x and xi thereof and inserting in lieu thereof in each case the words "five hundred and thirty".

8. Section 28 of The Workmen's Liens Act, 1893-1936, is amended by striking out the words "four hundred and ninety" therein and inserting in lieu thereof the words "one thousand two hundred and fifty".

9. This Act shall apply to every action commenced after the commencement of this Act, whether the cause of action arose before or arises after the commencement of this Act.
