An Act to amend the Agent-General Act, 1901-1969; the Audit Act, 1921-1969; the Industrial Code, 1967-1969; the Licensing Act, 1967-1969; the Police Regulation Act, 1952-1969; the Public Service Act, 1967-1969; the Public Service Arbitration Act, 1968-1969, and the Local Courts Act Amendment Act, 1969, and for other purposes.

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

(b) by inserting after the word "salaries" in subsection (2) of section 5e as so enacted, the passage "and any arrears of salary whenever accruing".
