An Act to amend the Artificial Breeding Act, 1961-1974.

[Assented to 12th December, 1974]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

1. (1) This Act may be cited as the "Artificial Breeding Act Amendment Act, 1974". Short titles.

(2) The Artificial Breeding Act, 1961-1974, is hereinafter referred to as "the principal Act".

(3) The principal Act, as amended by this Act, may be cited as the "Artificial Breeding Act, 1961-1974".

2. Section 3 of the principal Act is amended—

(a) by inserting immediately before the definition of "board" the following definition:—

"agreement" means an agreement entered into by the board pursuant to section 24a of this Act and includes such an agreement as amended or varied pursuant to that section;

and

(b) by inserting after the definition of "Minister" the following definition:—

"prescribed person" means a person or body with whom the board has for the time being entered into an agreement:.

3. Section 22 of the principal Act is amended—

(a) by inserting in subsection (1) after the word "board" first occurring the passage "or a prescribed person";

(b) by striking out from subsection (1) the passage "the board" second occurring and inserting in lieu thereof the passage "this Act or an agreement";

(c) by inserting in subsection (2) after the word "board" first occurring the passage "or a prescribed person";

and

(d) by striking out from subsection (2) the passage "the board" second occurring and inserting in lieu thereof the passage "this Act or an agreement".

4. The following section is enacted and inserted in the principal Act immediately after section 24 thereof:—

Agreement by
the board.

24a. (1) The board may, with the approval of the Minister, enter into and carry out an agreement with a person or body where that agreement provides for the carrying out by the person or body of all or any of the duties and functions of the board under this Act and the board may with the approval of the Minister from time to time enter into an agreement amending or varying that first-mentioned agreement.

(2) Without limiting the generality of the matters that may be the subject of an agreement the agreement may provide for the sale or other disposition of any real or personal property of the board.

5. Section 26 of the principal Act is amended by inserting immediately after paragraph (b) the following paragraph:—

(ba) for prescribing standards for bulls from which semen may be collected or used for artificial insemination of stock, for prohibiting or regulating the collection or use of semen otherwise than in accordance with the regulations;
